BUSINESS UPDATE

This announcement is made by Mindtell Technology Limited (the “**Company**”, together with its subsidiaries, the “**Group**”), on a voluntary basis to inform its shareholders and potential investors about the latest business development of the Group.

Reference is made to the announcement of the Company dated 5 June 2025 (the “**Announcement**”), in relation to the authorization granted to its indirect wholly-owned subsidiary, Henan Lixuan Network Technology Co., Ltd. (“**Henan Lixuan**”), to use the name “Jiufulai International” in its business with cooperative partners. Unless the context otherwise requires, terms used in this announcement shall have the same meanings as defined in the Announcement.

Since the publication of the Announcement, Henan Lixuan has actively expanded its market presence and developed cooperative merchants, achieving notable progress. As at the date of this announcement, Henan Lixuan has established cooperation with more than 4,000 merchants, with business coverage across over 29 provincial-level regions in Mainland China. From the completion of the Group’s acquisition of Henan Lixuan up to the date of this announcement, the cumulative gross merchandise value generated from such cooperation has exceeded RMB150 million (unaudited). These collaborations demonstrate the effectiveness of the Group’s authorized operating model and lay a solid foundation for future business growth.
